2. Nomination papers **must** be delivered by hand to the Returning Officer, c/o The Election Services Office, Ground Floor, Council Offices, London Road, Saffron Walden, Essex, CB11 4ER on any day from the date of this notice, Monday to Friday between 9am and 4pm but no later than 4pm on Tuesday 4 April 2023.
3. If any election is contested the poll will take place on **Thursday 4 May 2023**.
4. Applications to register to vote **must** reach the Electoral Registration Officer by 12 midnight on Monday 17 April 2023. Applications can be made online at [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote)
5. Applications, amendments or cancellations of postal votes **must** reach the Electoral Registration Officer at Council Offices, London Road, Saffron Walden, Essex, CB11 4ER by 5pm on Tuesday 18 April 2023.
6. Applications to vote by proxy at this election **must** reach the Electoral Registration Officer at Council Offices, London Road, Saffron Walden, Essex, CB11 4ER by 5pm on Tuesday 25 April 2023.
7. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on Tuesday 25 April 2023. Applications can be made online: [www.gov.uk/apply-for-photo-id-voter-authority-certificate](http://www.gov.uk/apply-for-photo-id-voter-authority-certificate)
8. Applications to vote by emergency proxy at this election applied for on grounds of physical incapacity, work or service reasons or where the elector's photo identification (including a Voter Authority Certificate) is lost, stolen or damaged beyond use after 5pm on Tuesday 25 April 2023, **must** reach the Electoral Registration Officer at Council Offices, London Road, Saffron Walden, Essex, CB11 4ER by 5pm on Thursday 4 May 2023.
9. The above poll will be combined with the poll for the election of District Councillors.
